What could be more frustrating than a stock that is piling up? We will help you draw up a schedule to manage your inventory optimally.

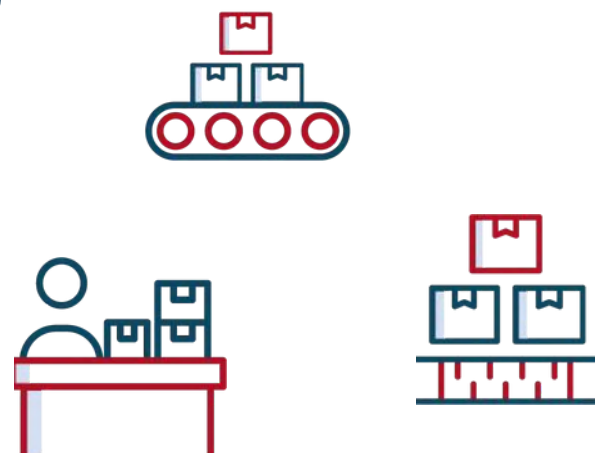

Quality control - Inspection Service

Our quality control teams are your guarantee of trust in the field. The production verification process is based on an approach that can be adapted to each case. We follow international control standards such as ANSI / ASQC Z1.4-2003, AQL, and ISO 2859-1. We even recommend going beyond them depending on the type of order and product.

In fact, we ensure a customized inspection service carried out in a flexible manner in terms of timing and with the delivery of a report within 24 hours.



Audit and compliance

Our audit and compliance teams have strong expertise in the legal and regulatory aspects of import legislation. If you wish to import under a **white label** (private label), or simply to be sure that the goods comply with the directives (European for example) and national legislations. We make you benefit from our experience to offer you the guarantee of not having any complication during the customs clearance, but also on the domestic market of your choice. Therefore we impose strong requirements on ourselves as regards the substance of this approach - test report, certificate of conformity, declaration of conformity - but also in the form - respect of the application decrees concerning the markings, labeling, user guide...
